

## Mullingar EC Refund Policy re SJI Entries

-Entries for SJI events must be made through [www.sjilive.ie](http://www.sjilive.ie) & paid in full as per conditions at the time of booking.

-**For Mullingar SJI Shows (except the CSI 2\*)** the deadline for refunds re entries **is the official closing time** for that shows entries

**To avail of a refund** (with the exception of the classes listed below ) withdrawals must be made on SJI Live through my declarations **before the close of entry as per the SJI LIVE App for that show**, a €5 admin fee will be retained for each entry. There are no refunds for any entry not withdrawn before the close of entry except in exceptional circumstances & the rider/owner must contact the show office/judges before the class starts to say that they are not jumping & all efforts will be made to move that entry to another show or league day .

### Mullingar CSI 2 \* Horse Show 2026 May 22nd to June 3rd

Entries must be paid in full at time of booking & there are no refunds after the **first days official entry closing time**

Every effort will be made to facilitate entries not jumped by moving them to another class, this does not include FINALS /championships.

Pony Masters entries close at 18.00 on Monday May 11th & there will be no refunds

We may as show organisers close entries earlier than advertised subject to numbers submitted or move classes , arenas or start times as appropriate. **Grand Prix/Premiers:** Refunds will not be issued for National Horse Grand Prix, Premier GP, Pony Premiers/ Star-finder, Mervue GP , Spring Tours, Autumn GP unless a vet cert is submitted to [info@mullingarequestrian.com](mailto:info@mullingarequestrian.com) **within 3 days of the show finishing.**

All entry fees include a €1.50 show jumping Ireland levy

**Prizemoney :** Prizemoney will be paid out on the day ( 1 to 6) & must be collected at the prize giving ceremony or in the show office on the day of the show, with the exception of Grand Prixs and classes over the value of €1000 , Ibans must be submitted re same within 3 days of the show finishing .  
IT IS VERY IMPORTANT from 2026 onwards that the exact name of the PAYEES account as per the bank statement must be submitted ,as if the names do not match, prize money cannot be paid

### **Waiver & Risk Advisory** Notice to include all events & training at Mullingar Equestrian Centre

1. I acknowledge and agree that I understand the nature or horse riding and its associated activities and the inherent risks involved in these activities including participation in any shows, training or schooling at Mullingar Equestrian Centre.
2. I acknowledge and agree that I understand the associated activities will include loading, unloading, leading, washing, grooming, holding and all other activities that may arise from participation at the venue.
3. I understand and I accept the high risk involved in riding and competing in shows.
4. I understand and I accept that horse riding can result in serious injury or death.

5. I understand it is my responsibility to ensure that safety clothing and equipment such as helmets, back protectors and footwear, as well as tack on the horse or pony is appropriate and up to standards and is worn when appropriate.
6. I confirm that I or the participant I am entering to partake at the venue is experienced, competent and in proper physical condition to participate.
7. I confirm that the animal that is being entered is suitable to partake in the activities and capable to compete at the level entered.
8. I accept that it is our responsibility to walk courses and familiarise ourselves with the protocols of the event or training.
9. I acknowledge that I am also accepting the risk for ALL PARTIES I bring with me or are associated with my participation at this venue.
10. I acknowledge that I am also accepting the risks of injury to THIRD PARTIES and/or DAMAGE TO PROPERTY arising from our participation and I have appropriate PUBLIC LIABILITY INSURANCE COVER to indemnify me in the event of any incident.
11. Dogs or accompanying animals must be under the control of persons responsible at all times.

By completing an entry/booking transaction, I am aware of the "Risk" involved in horse riding and the associated risks in handling an equine on the ground and have made the participant(s) I am in charge of /or entering, aware of the risks and I acknowledge and accept the risks involved. If in charge of minors I will ensure they are supervised at all times. **I agree I will not hold Mullingar Equestrian Centre Ltd or their owners, agents, employees or any representative person responsible** for any accident, damage, injury (including shock or distress) howsoever sustained which does not arise from a negligent act or omission of Mullingar Equestrian Centre Ltd
